

# **2025 ENTRY REQUIREMENTS**

## **FOR ALL HORSES ENTERING BALLY'S ARAPAHOE PARK RACETRACK**

*(Revised 08/07/2025)*

### **SUMMARY:**

- **CVI - Certificate of Veterinary Inspection** (Health certificate)
  - within **5 days** of entry for **Thoroughbred/covered horses** and Thoroughbred associated **Pony horses** (*HISA Rule 2143*)
  - within **30 days** of entry for **ALL** other equidae (Quarter Horses, Arabians, pony and outrider horses, and all companion/stable ponies, donkeys, etc)
- **COGGINS (Equine Infectious Anemia test (EIA))**
  - **ALL horses** (Thoroughbreds & Quarter Horses) - within **30 days** of entry.
- **PIROPLASMOSIS**
  - **Quarter Horses** (cELISA for T. equi) - within **365 days** of entry

### **ENTRY REQUIREMENTS DETAILS**

- 1) A **Certificate of Veterinary Inspection (CVI)** - within (**5 days** for Thoroughbreds and **30 days** for ALL other horses) of arrival, (including stable ponies).
  - a) At a minimum the following information must be included:
    - **Place of Origin:** Contact name, location, phone, email
    - **Destination Information:** Point of contact, location, phone, email
    - **Veterinarian Information:** Name, Clinic, Accreditation Number, License Number and Address
    - **Horse's identifiable factors:** Breed, sex, color, age, permanent identification (microchip, tattoo)
    - **Equine infectious anemia (EIA) test information:** Test result, date of test, lab where testing occurred, lab ID number
    - **Vaccine information:** Must include injection dates and type of vaccine
    - **Certificate of Veterinary Inspection (CVI):** Number, issue date
    - **Transport information:** Date, purpose of movement

## **2025 ENTRY REQUIREMENTS**

- 2) Negative **Coggins test** (EIA) - for **ALL** species and breeds of equidae. All horses stabled at Bally's Arapahoe Park must have a current negative Coggins (EIA) test (*drawn within 30 days*) on file in the racing office, and with the Division Veterinarian.
- 3) Negative **Piroplasmosis cELISA test**, *T. equi* species, for **ALL Quarter Horses** - within **365 days**.

\*\*\* If the Piroplasmosis test expires during the Meet, it must be redone.

All required testing must be performed and completed prior to arriving at Bally's Arapahoe Park. No horse(s) will be permitted to enter the grounds without the above testing having been completed and without proper documentation, including results.

**Should anyone bring horses to the racetrack WITHOUT current test results, that person and their horses will be turned away and will not be allowed access to the grounds.**

### **VACCINATIONS:**

The following vaccinations are required for **all species and breeds** (Thoroughbreds/covered horses, Quarter Horses, Arabians, pony and outrider horses, and all companion/stable ponies, donkeys, etc.)

The Colorado Racing Commission is currently following **HISA** vaccination guidelines to protect all equidae on the backside. Please ask your veterinarian to check current HISA vaccination requirements (Rule 2143) and to include the vaccination information on the CVI (health certificate).

- a) **Eastern Equine Encephalomyelitis (EEE)** -within 365 days
- b) **Western Equine Encephalomyelitis (WEE)** - within 365 days
- c) **West Nile Virus (WNV)** within 365 days
- d) **Rabies** - within 365 days
- e) **Tetanus** - within 365 days
- f) **Equine influenza and rhinopneumonitis (aka EHV):** within 180 days

A proper series of vaccinations, with an initial vaccination followed by a booster shot in approximately 3 weeks, is **strongly** encouraged (*but not required*) for equine diseases listed in items 4a, 4b, 4c, and 4f.



## **2025 ENTRY REQUIREMENTS**

**NO IN/OUT PRIVILEGES.** (Emergency situations may qualify for an exception, please contact the Stewards, Head of Security or Racing Office.)

For all horse(s) leaving the grounds, supply the following information to the racing office:

- (1) Horse Identification
- (2) Intended Destination
- (3) Reason for departure
- (4) Date of exit
- (5) Vehicle License Plate
- (6) Transporter Name

### **RE-ENTRY REQUIREMENTS TO BALLY'S ARAPAHOE PARK GROUNDS:**

- 1) Certificate of Veterinary Inspection (CVI) dated within **30 days** of re-entry
- 2) Negative Coggins test within:
  - a) **30 days** for all **Quarter horses**
  - b) **365 days** for all other breeds.
- 3) Negative Piroplasmosis, *T.equi* species, test for racing **Quarter Horses** within **30 days**.
- 4) Re-entry approval from the General Manager of Arapahoe Park

If the required testing utilized for the initial entry expires, new testing must be completed prior to re-entry.

**\*\*Please note these requirements are applicable to ALL species and breeds of equidae, unless noted otherwise.**

**NOTE: Arapahoe Park equine entry requirements are subject to revision if outbreaks or other high risk situations arise.**
