**Ship in Requirements to Bally's Arapahoe Park**  
**RACING THOROUGHBREDS:** Negative Coggins dated within one year of arrival.  
Negative Health Certificate dated within 30 days before arrival.  
**RACING QUARTER HORSES:** Negative Coggins dated within 30 days of arrival. Negative Piroplasmosis test dated  
within 30 days of arrival. Piroplasmosis test must include results for both types of protozoa: THEILERIA and  
BABESIA CABALLI. A Health Certificate dated within 30 days before arrival.  
**PONY HORSES:** Negative Coggins dated with in one year of arrival. Negative Health Certificate dated within 30  
days of arrival.  
**ANY HORSE** that leaves the barn area and seeks RE-ENTRY must meet the ship in requirements for their particular  
distinction/breed before re-entry.

### RULES and ELIGIBILITY

1. Stall Applications must include PP's and be signed on the front and back to receive consideration.
2. Do NOT ship horses until you have been notified of stall allotment.
3. Any horse entered for racing must be present on the grounds at least 48 hours prior to the scheduled post time of the first race in which the horse is entered on any given calendar day.
4. To be considered for RV spot you must not owe rent from previous years.

# Stall Application for Bally's Arapahoe Park

1. The statutes of the State of Colorado, rules and regulations of the Colorado Racing Commission, and the Horsemen's Association recognized by Bally's Arapahoe Park (collectively "Rules") shall apply to the race meet to be conducted at the track, and Applicant agrees to be bound by them. In consideration of stalls allotted by Bally's Arapahoe Park to the Applicant, the Applicant accepts the conditions and policies of racing established by Bally's Arapahoe Park.

2. Bally's Arapahoe Park reserves the right to cancel or amend any race.

3. A registration certificate, relating to a horse, must be on file with the Racing Secretary before the entry of the horse is accepted, stakes races excluded.

4. Applicant shall be liable for its own acts and omissions, as well as those of its officers, agents, independent contractors, representatives and employees (together, "Representatives"). Applicant agrees to require its Representatives to strictly comply with the Rules. Applicant further agrees that it has sole responsibility for the safety and well being of its Representatives.

5. Bally's Arapahoe Park (BAP) reserves all rights to photographs, video tapes, television and motion pictures filmed or produced for non-income or noncommercial use. All entries will be accepted on the condition that if requested by BAP, the owner, trainer, groom, jockey and all other persons associated with the Applicant who may come into camera range, will sign a formal release permitting the taking of photographs, video tape, filming of such television or motion pictures, and the subsequent exhibition thereof.

6. In consideration of the allotment of stalls by BAP, hot and cold running water and electricity in stables and facilities located on the premises of BAP, the Applicant agrees to enter his/her horses when they are fit to run and suitable races are programmed. Applicant's horses will not be withheld as entries for any reason other than illness or inability to run for other valid causes. Applicant agrees to vacate the stalls allotted to him/her and to remove horses, equipment, and personnel from the premises of BAP within seventy-two (72) hours after being notified to do so.

7. The Applicant and all personnel under his/her control will refrain from smoking or using alcoholic beverages in the barn area. Possession of alcohol is prohibited in the barn area. The Applicant is responsible for the overall cleanliness of their assigned areas. The area shall extend from their assigned stalls to the roadway. This overall cleanliness includes, but is not limited to trash, weeds, and other debris.

The Applicant is responsible for any damage caused to the assigned area by the Applicant and its Representatives. No alterations may be made to the assigned area without prior approval by BAP. No living or cooking is permitted

in or about the barns. No pets are permitted on the backstretch and barn area.

8. This application, or its acceptance by BAP, shall not be construed as a lease of any particular space at BAP, but, upon acceptance of BAP, merely constitutes a revocable license or permit under the terms and conditions herein set forth. The signature of the Applicant on this Application is an acknowledgment that this applicant agrees to be subject to the terms and conditions hereof.

9. Bally's Arapahoe Park reserves the right to exclude any horse or horseman from participating in the 2025 meet for any reasons including but not limited to: drug violations, qualifications, participating in programs, poor performance or any conduct not considered beneficial to the overall racing program at Bally's Arapahoe Park.

## WORKERS COMPENSATION

Colorado Law requires all individual employers to carry Workers Compensation Insurance covering all employees. This coverage must include all individuals employed by owners and trainers in the training of horses. All concessionaires shall carry Workers Compensation Insurance covering all employees.

## WAIVER AND INDEMNITY

The undersigned, in consideration of the allotment of stalls at Bally's Arapahoe Park, does hereby waive, release and forever hold harmless Racing Associates of Colorado, Ltd., d/b/a Bally's Arapahoe Park, its officers, agents, representatives, employees, affiliates, and any others acting on behalf of Bally's Arapahoe Park (hereinafter the "Indemnified Parties"), from any and all liability for any loss, damage or destruction or injury to any person, horse or other personal property owned or leased by the Indemnified Parties, except to the extent the loss, damage, destruction or injury is caused solely by the negligence of any of the Indemnified Parties. The undersigned agrees to forever indemnify and reimburse the Indemnified Parties for any and all fees, expenses, costs or damages caused by the undersigned and its Representatives for any horse, person, property owned, leased or borrowed by the undersigned, while on the premises owned or leased by the Indemnified Parties.

## FIRE MARSHAL ORDER:

Tack Room/Storage Spaces can NOT be used as living spaces, no sleeping & no cooking. Using these spaces for sleeping and living spaces is prohibited, it violates the International Fire Code adopted by South Metro Fire Rescue and ratified by Arapahoe County.
