BALLY BET SPORTSBOOK HOUSE RULES

1. Bally Bet may update, amend, edit and supplement these House Rules at any time.
2. Bally Bet Sportsbook makes every effort to ensure no errors are made in prices offered or bets accepted. However human, mechanical or technical errors occasionally result in errors. Bally Bet Sportsbook reserves the right to correct any obvious errors and to void bets where such errors have occurred.
3. The following persons are prohibited from placing wagers through Bally Bet's sportsbook platform:
 - Excluded or Self-Excluded Patrons pursuant to N.J.A.C. 13:69G;
 - Any casino or gaming key employee licensee;
 - Anyone under the age of 21;
 - Any individual placing a wager or collecting winnings as an agent or proxy
4. Any person who is an athlete, coach, referee, direct or indirect owner of 10% or greater, or director of a sports governing body or any of its team members, a player or a referee personnel member, in or on any sports event overseen by that person's sport's governing body, a person who holds a position of authority or influence sufficient to exert influence over the participants in a sporting contest, including, but not limited to, coaches, managers, handlers, athletic trainers or horse trainers, a person with access to certain types of exclusive information on any sports event overseen by that person's sport's governing body. Or a person identified by any lists provided by the sport's governing body to the New Jersey Division of Gaming Enforcement or the New Jersey Racing Commission, may not place a wager on a sports event that is overseen by that person's sport's governing body.
5. Bally Bet Sportsbook has the right to determine minimum and maximum wager limits on all events, including wager by wager basis.
6. Bally Bet Sportsbook has maximum daily payout limits that apply on a per event basis.
7. Bally Bet Sportsbook reserves the right to refuse any wager or delete or limit any selection(s) prior to the acceptance of a bet.
8. Bally Bet Sportsbook is not responsible for lost, stolen or unreadable tickets.
9. Patrons should verify accuracy of tickets before leaving the window or kiosk. Management is not responsible for errors on a ticket once the patron leaves the window or kiosk. A ticket may not be altered or voided prior to the event, except at the discretion of sportsbook management.
10. Winning tickets may be mailed-in for redemption. See reverse side of ticket for mail-in instructions. Bally Bet Sportsbook is not responsible for tickets that are mailed in not in compliance with printed instructions.
11. Winning tickets expire one year from completion of the event date.
12. All odds offered are subject to variation. Such fluctuation is determined solely at Bally Bet's discretion. Bets are accepted only at the odds available in the betting grid at the time the bet was accepted.
13. Calculations for payouts are as follows.
 - A. Moneyline: Money line is displayed as a three-digit number. -120 means a player must wager \$120 to win \$100. +120 means a player will win \$120 for a \$100 wager.
 - B. Points spread: Point spread will be listed with a minus number and a three-digit number. Team A -3 -110 which means if a player makes a wager on Team A they need to win by more than 3 to win but the player needs to wager \$110 to win \$100. Team B in this example would be +3 -110. If Team B loses by less than 3 or win the game the player wins but needs to wager \$110 to win \$100. If the final score lands on 3, it is a push and money is returned to players.

15. Please ask at the window for the effects of a change in schedule. Each sport has different rules and venue changes or any change in schedule.
16. Current odds will be posted on electronic boards in the sports book and will be posted on the kiosks.
17. Any employee of a sports governing body, or one of its member teams, who is not a prohibited sports pool participant must register with the New Jersey Division of Gaming Enforcement prior to placing a sports pool wager.
18. Patrons may fund wagers via the following methods:
 - a. Retail betting window accepts cash, chips, winning tickets and kiosk vouchers.
 - b. Kiosks accept cash, kiosk vouchers or winning tickets up to kiosk deposit limit.
